H. J. Adriaanse is Professor Emeritus of the Philosophy of Religion and Ethics at the University of Leiden and a Member of the Royal Dutch Academy of Sciences. Among his books are *Vom Christentum aus* (1995), *Theology and Rationality* (co-edited with H. A. Krop, 1988), *The Phenomenon Called Theology* (co-authored with H. A. Krop and L. Leertrouwer, 1987), *Zu den Sachen selbst: Versuch einer Konfrontation der Theologie Karl Barths mit der phänomenologischen Philosophie Edmund Husserls* (1974), and the edited volume *On Philosophical and Confessional Theology*.

Alena Alexandrova is a Ph.D. student at the Amsterdam School for Cultural Analysis, University of Amsterdam. She is also a guest researcher at the Heyendaal Institute, University of Nijmegen, and a co-editor of *Retreating Religion: Deconstructing Christianity with Jean-Luc Nancy*, together with Ignaas Devis, Laurens ten Kate, and Aukje van Rooden. She has published articles in the field of aesthetics and visual studies.

Talal Asad was born in Saudi Arabia and educated in Britain. He now teaches anthropology at the Graduate Center of the City University of New York. His most recent book is entitled *Formations of the Secular: Christianity, Islam, Modernity* (2003).

Jan Assmann is Professor of Egyptology at the University of Heidelberg. His most recent publications in English include *Religion and Cultural Memory: Ten Studies* (2006), *Death and Salvation in Ancient Egypt* (2005), *The Mind of Egypt: History and Meaning in the Time of the Pharaohs* (2002), *The Search for God in Ancient Egypt* (2001), and *Moses the Egyptian: The Memory of Egypt in Western Monotheism* (1998).

Henri Atlan is Professor Emeritus of Biophysics at the University of Paris VI and the Hebrew University of Jerusalem. In addition to being Director of the Human Biology Research Center and Scholar in Residence for studies in Philosophy and Ethics of Biology at the Hadassah University Hospital, Jerusalem, he is Honorary Head of the Department of Biophysics of the Hotel-Dieu Hospital and Director of Research in Philosophy of Biology at the École des Hautes Études en Sciences Sociales, both in Paris. He was a member of the French National Committee of Ethics for Health and Life Sciences and has won an international reputation for his research on the self-organization of cells, theories of

complexity, immunology, and artificial intelligence. Among his published works are *L'utérus artificiel* (2005), the two-volume *Les étincelles de hasard* (1999), *Enlightenment to Enlightenment: Inter critique of Science and Myth* (1986), *Entre le cristal et la fumée: Essai sur l'organisation du vivant* (1979), and *L'organisation biologique et la théorie de l'information* (1972).

Stef Aupers is a sociologist of culture, an Assistant Professor at Erasmus University Rotterdam, and a member of the Amsterdam School for Social Science Research (ASSR). He has published widely on post-traditional forms of spirituality, conspiracy culture, cyberculture, and online computer gaming.

Daniel Boyarin is the Taubman Professor of Talmudic Culture in the Departments of Near Eastern Studies and Rhetoric at the University of California, Berkeley. Among his recent books are *Border Lines: The Partition of Judaeo-Christianity* (2004), *Dying for God: Martyrdom and the Making of Christianity and Judaism* (1999), and *Unheroic Conduct: The Rise of Heterosexuality and the Invention of the Jewish Man* (1997).

Jan N. Bremmer is Professor of Religious Studies at the University of Groningen. Among his books are *Greek Religion and Culture, the Bible, and the Ancient Near East* (2008), *The Rise and Fall of the Afterlife* (2002), *Greek Religion* (1994), *Roman Myth and Mythography* (co-authored with Nicholas Horsfall, 1987), and *The Early Greek Concept of the Soul* (1983).

Thomas A. Carlson is Professor in the Department of Religious Studies at the University of California, Santa Barbara. He is the author of *Indiscretion: Finitude and the Naming of God* (1999) and of *The Indiscrete Image: Infinitude and Creation of the Human* (2008), a study of human self-creation in contexts of mystical theology and technological modernity. He has also translated into English several works by Jean-Luc Marion, including *God Without Being* (1991), *Reduction and Donation: Investigations of Husserl, Heidegger, and Phenomenology* (1998), and *The Idol and Distance* (2001).

José Casanova is Professor of Sociology at Georgetown University and Senior Fellow at its Berkley Center for Religion, Peace, and World Affairs. He has published widely on sociological theory, migration, and globalization, and he is the author of *Public Religions in the Modern World* (1994).

Job Cohen is Mayor of Amsterdam, a post he has held since January 15, 2001. Before that time, he was State Secretary of the Dutch Ministry of Justice, dealing chiefly with immigration, under Prime Minister Wim Kok. Prior to his entry into politics as a member of the Labor Party (PvdA), he was Professor of Methods and Techniques in the Faculty

of Law of Maastricht University, and then the university's Rector Magnificus. In 2005, *Time* magazine awarded him the title "European hero."

Veena Das is Krieger-Eisenhower Professor at The Johns Hopkins University, where she teaches in the Department of Anthropology. She is a Foreign Fellow of the American Academy of Arts and Sciences and the Third World Academy of Sciences. She has published widely on questions of social suffering and violence. The last two books she has authored are *Life and Words: Violence and the Descent into the Ordinary* (2006) and *Critical Events: An Anthropological Perspective on Contemporary India* (1995).

Régis Debray teaches philosophy at the Université de Lyon–III and is director of the European Institute of the History and Science of Religion at the École Pratique des Hautes Études, in Paris. He is the author of many books, including *Le feu sacré: Fonction du religieux* (2003), *God, an Itinerary* (2001), and *Media Manifestos: On the Technological Transmission of Cultural Forms* (1996). His life has intersected with some of the key moments of the twentieth century: from his involvement with the Cuban revolution and his arrest in 1967 in the Bolivian jungle, where he had followed the traces of Che Guevara; to the state offices of the Elysée Palace, where he served as an advisor to François Mitterrand in the early 1980s, to his membership in the Stasi Commission, which proposed the 2003 French law on conspicuous religious in public schools.

Jacques Derrida was Director of Studies at the École des Hautes Études en Sciences Sociales, Paris, and Professor of Humanities at the University of California, Irvine. Among his most recent works to be published in English are *Geneses, Genealogies, Genres and Genius: The Secrets of the Archive* (2006), *Sovereignities in Question: The Poetics of Paul Celan* (2005), and, with Giovanna Borradorri, *Philosophy in a Time of Terror: Dialogues with Jürgen Habermas and Jacques Derrida* (2003).

Willem B. Drees holds the chair in philosophy of religion and ethics at Leiden University and is dean of its Faculty of Religious Studies. He also serves as president of ESSSAT, the European Society for the Study of Science and Theology. Among his published works are *Creation: From Nothing until Now* (2002), *Religion, Science and Naturalism* (1996), and *Beyond the Big Bang: Quantum Cosmologies and God* (1990), as well as edited volumes such as: *Creation's Diversity: Voices from Theology and Science* (2008), *The Study of Religion and the Training of Muslim Clergy: Academic and Religious Freedom in the 21st Century* (2008), and *Is Nature Ever Evil? Religion, Science and Value* (2003).

André Droogers is Emeritus Professor of Cultural Anthropology, especially Anthropology of Religion and Symbolic Anthropology, at the VU University Amsterdam. He is Director

of the Hollenweger Center for the Interdisciplinary Study of Pentecostal and Charismatic Movements. His numerous publications address various themes, such as Pentecostalism, syncretism, religion and play, the changing worldviews in The Netherlands, and religion and power. With Sidney M. Greenfield, he recently edited the collective volume *Re-inventing Religions: Syncretism and Transformation in Africa and the Americas*. He is the coordinator of research programs on changing worldviews in The Netherlands and on conversion careers and culture politics in Global Pentecostalism.

France Guwy is a Belgian journalist. She has worked for Belgian and Dutch television, radio, and newspapers, specializing in literature and philosophy. She has published books about passion and about the ideas of Voltaire and has translated French philosophy.

Annemie Halsema is Assistant Professor in the Department of Philosophy of the VU University Amsterdam, where she teaches gender studies and social philosophy. She has published in the field of feminist philosophy, especially on Irigaray, Benjamin, and Butler. She is currently engaged in a project on the otherness of the self in the work of Ricoeur, Irigaray, Benjamin, and Butler.

Danièle Hervieu-Léger is Director of Studies at the École des Hautes Études en Sciences Sociales, Paris, Director of the Centre Interdisciplinaire d'Études des Faits Religieux, and editor-in-chief of *Archives de Sciences Sociales des Religions*. Among the most recent of her many books are *Catholicisme: Le fin d'un monde* (2003); *Le pèlerin et la converti: La religion en mouvement* (1999); and, in English translation, *Religion as a Chain of Memory* (2000).

Dick Houtman is Professor of Sociology of Culture at Erasmus University Rotterdam and a member of the Amsterdam School for Social Science Research (ASSR). His principal research interest is cultural change in contemporary Western society. Since the mid 1990s he has published about the emergence of a new political culture, central to which are cultural rather than class issues, and the way a spread of post-Christian spiritualities of life has accompanied the decline of the Christian churches. His latest books are *Farewell to the Leftist Working Class* (with Peter Achterberg and Anton Derks, 2007) and *Class and Politics in Contemporary Social Science: "Marxism Lite" and Its Blind Spot for Culture* (2003). He is currently editing a book with Stef Aupers, provisionally titled *Religions of Modernity: Relocating the Sacred to the Self and the Digital*.

Michael Lambek is Professor of Anthropology at the University of Toronto and the London School of Economics. Among his most recent books are *The Weight of the Past: Living with History in Mahanja, Madagascar* (2003), the edited volume *A Reader in the Anthropology of Religion* (2002), and *Bodies and Persons: Comparative Perspectives from Africa and Melanesia* (with Andrew Strathern, 1998).

Niklaus Largier is Professor of German Literature and former director of the religious studies program at the University of California, Berkeley. Among his books are *In Praise of the Whip: A Cultural History of Arousal* (2007) and *Zeit, Zeitlichkeit, Ewigkeit: Ein Aufriss des Zeitproblems bei Dietrich von Freiberg und Meister Eckhart* (1989). He is the editor of the selected writings of Meister Eckhart in German.

Emmanuel Levinas was Professor of Philosophy at the University of Paris–Sorbonne Paris IV and Director of the École Normale Israélite Orientale. The most central of his many books to be published in English translation are *Totality and Infinity: An Essay on Exteriority* (1969) and *Otherwise than Being; or, Beyond Essence* (1981).

Sander van Maas is Assistant Professor of Musicology at the University of Amsterdam and Lecturer in Music Aesthetics at the Amsterdam Conservatory. His research activities include a project on new music and the turn to religion, which focuses on philosophical questions regarding the historical and structural possibility of contemporary “spiritual” or “religious” art music. His book publications include an interdisciplinary study on Olivier Messiaen and the reinvention of religious music, forthcoming in a revised English-language version. He is chairman of the Dutch Association of Aesthetics (NGE) and editor of several online journals.

Jean-Luc Marion is Professor of Philosophy at the University of Paris–Sorbonne Paris IV and the John Nuveen Professor at the Divinity School and Professor in the Committee on Social Thought and the Department of Philosophy at the University of Chicago. Among his most recent books to appear in English translation are *On the Ego and on God: Further Cartesian Questions* (2007), *The Erotic Phenomenon* (2007), *Prolegomena to Charity* (2002), *In Excess: Studies of Saturated Phenomena* (2002), and *Being Given: Toward a Phenomenology of Givenness* (2002).

Tomoko Masuzawa is Professor of History and Comparative Literature at the University of Michigan. She specializes in the history of the human sciences in the nineteenth and twentieth centuries, especially European academic discourses on religion. She is the author of *The Invention of World Religions; or, How European Universalism Was Preserved in the Language of Pluralism* (2005) and *In Search of Dreamtime: The Quest for the Origin of Religion* (1993).

Birgit Meyer is Professor of Cultural Anthropology in the Department of Social and Cultural Anthropology at the VU University Amsterdam. She has conducted research on missions and local appropriations of Christianity, Pentecostalism, popular culture, and video films in Ghana. Her publications include *Religion, Media, and the Public Sphere* (co-edited with Annelies Moors, 2005), *Magic and Modernity: Interfaces of Revelation and*

Concealment (co-edited with Peter Pels, 2003), *Globalization and Identity: Dialectics of Flow and Closure* (co-edited with Peter Geschiere, 1999), and *Translating the Devil: Religion and Modernity among the Ewe in Ghana* (1999).

Arie L. Molendijk is Professor of the History of Christianity at the University of Groningen. His publications include *The Emergence of the Science of Religion in the Netherlands* (2005), *Post-Theism* (co-edited with Henri A. Krop and Hent de Vries, 2000), *The Pragmatics of Defining Religion: Contexts, Concepts, Contests* (co-edited with Jan G. Platvoet, 1999), and *Zwischen Theologie und Soziologie: Ernst Troeltschs Typen der christlichen Gemeinschaftsbildung: Kirche, Sekte, Mystik* (1996).

Jean-Luc Nancy is Distinguished Professor of Philosophy at the University Marc Bloch, Strasbourg. The most recent of his many books to be published in English are *Dis-Enclosure* (2008), *Philosophical Chronicles* (2008), *Listening* (2007), *The Creation of the World; or, Globalization* (2007), and *The Ground of the Image* (2005).

David Nirenberg is Professor in the Committee on Social Thought and the Department of History at the University of Chicago. In addition to his historical work on relations between Christians, Jews, and Muslims in the Middle Ages, as exemplified in his *Communities of Violence: Persecution of Minorities in the Middle Ages* (1998), he is interested in how the possibilities and limits of community and communication have been imagined. He is pursuing that interest through two parallel projects. The first is a history of love's place in a number of idealizations of communication and exchange; and the second, a study of poison as a representation of communication's dangers.

Willemien Otten is Professor of the Theology and History of Christianity at the University of Chicago Divinity School. Her work focuses on medieval concepts of nature and creation, particularly its religious aspects, as evidenced by her publications *From Paradise to Paradigm: A Study of Twelfth-Century Humanism* (2004) and *The Anthropology of Johannes Scottus Eriugena* (1991).

Peter Pels is Professor of African Anthropology at the University of Leiden. He has published on critical anthropological theory, the anthropology of colonialism, the history of anthropology, modern African politics and religion, and material culture. His publications include *Cultures of Voting* (with Romain Bertrand and Jean Louis Briquet, 2007), *Embedding Ethics* (with Lynn Meskell, 2005), and *Magic and Modernity: Interfaces of Revelation and Concealment* (co-edited with Birgit Meyer, 2003). He is currently working on cyberculture, science fiction, and the comparative study of the future.

M. B. Pranger is Professor of the History of Christianity at the University of Amsterdam. In his publications, which are mainly on medieval monasticism, he focuses on the relationship between religion and literature. His most recent book is *The Artificiality of Christianity: Essays on the Poetics of Monasticism* (2003), and he is currently completing a book on Augustine and Henry James, provisionally entitled *Augustinian Soundings*.

Patricia Spyer is Professor of Anthropology at the University of Leiden. She is the author of *The Memory of Trade: Modernity's Entanglements on an Eastern Indonesian Island* (2000) and the editor of *Border Fetishism: Material Objects in Unstable Spaces* (1998).

Jeremy Stolow is Assistant Professor in the Department of Sociology and the Department of Communication Studies and Multimedia at McMaster University, where he is also an associate member of the Department of Religious Studies and the Institute on Globalization and the Human Condition. His area of research is religion and media, with a particular interest in religion and technology.

Winnifred Fallers Sullivan is Associate Professor of Law and Director of the Law and Religion Program at the University of Buffalo Law School, the State University of New York. She is the author of *The Impossibility of Religious Freedom* (2005) and is currently finishing a book about the impossibility of dis-establishment.

Asja Szafraniec is a postdoctoral fellow in the Department of Philosophy at the University of Amsterdam. She is the author of *Beckett, Derrida, and the Event of Literature* (2007). Her current research focuses on the relationship between philosophy, religion, and Romanticism in the work of Stanley Cavell.

Charles Taylor is Board of Trustees Professor of Law and Philosophy at Northwestern University, Professor Emeritus of Political Science and Philosophy at McGill University, and former Chichele Professor of Social and Political Theory at Oxford University. His most recent books include *A Secular Age* (2007), *Modern Social Imaginaries* (2004), and *Varieties of Religion Today: William James Revisited* (2002).

Peter van der Veer is University Professor at Utrecht University. He is also a Senior Fellow and a Distinguished Visiting Professor at the India-China Institute of the New School University in New York. He has published widely on religion and society, including *Imperial Encounters: Religion and Modernity in India and Britain* (2001), *Religious Nationalism: Hindus and Muslims in India* (1994), and *Gods on Earth* (1988). He is currently engaged in a comparative project on spirituality in India and China.

Peter Versteeg is an anthropologist and coordinator of the VU Institute for the Study of Religion, Culture and Society at the VU University Amsterdam. He has done research on

the religious experiences of Dutch neo-Pentecostals and has published about exorcism, alternative Christian spirituality, and liturgical change. Between 2003 and 2007 he was coordinator of the Hollenweger Center for Pentecostal Studies (VU University Amsterdam). He is among the co-editors of *Playful Religion: Challenges for the Study of Religion* (2006).

Hent de Vries holds the Russ Family Chair in the Humanities and is Professor of Philosophy at The Johns Hopkins University. He is also Professor Ordinarius of Systematic Philosophy and the Philosophy of Religion at the University of Amsterdam and Program Director at the Collège International de Philosophie, Paris. He is the author of *Minimal Theologies: Critiques of Secular Reason in Adorno and Levinas* (2005), *Religion and Violence: Philosophical Perspectives from Kant to Derrida* (2002), and *Philosophy and the Turn to Religion* (1999). Among the volumes he has co-edited are, with Lawrence E. Sullivan, *Political Theologies: Public Religions in a Post-Secular World* (2006), with Samuel Weber, *Religion and Media* (2001) and *Violence, Identity, and Self-Determination* (1998), and, with Henri A. Krop and Arie L. Molendijk, *Post-Theism: Reframing the Judeo-Christian Tradition* (2000).

Michael Warner is Professor of English Literature and American Studies at Yale University. He is the author of *Publics and Counterpublics* (2002), *The Trouble with Normal: Sex, Politics, and the Ethics of Queer Life* (2000), *The English Literatures of America, 1500–1800* (1996), and *The Letters of the Republic* (1992), and the editor of *Fear of a Queer Planet* (1993).

Tony Watling trained in anthropology at University College London and at the University of London, where he was a Wellcome Trust Research Fellow engaged in research on Christian religious responses to genetic engineering. His new publications involve eco-theological matters.

Samuel Weber is Avalon Professor of Comparative Literature at Northwestern University and Director of Northwestern's Paris Program in Critical Theory. He is the author of numerous books, most recently *Targets of Opportunity: On the Militarization of Thinking* (2005) and *Theatricality as Medium* (2004). He is the co-editor, with Hent de Vries, of *Religion and Media* (2001) and *Violence, Identity, and Self-Determination* (1998).

Angela Zito teaches in Anthropology at New York University, where she is Director of the Religious Studies Program and Co-Director of the Center for Religion and Media. Her book publications include *Of Body and Brush: Grand Sacrifice as Text/Performance in Eighteenth-Century China* (1997) and *Body, Subject, and Power in China* (edited with Tani E. Barlow, 1994).
